DIRECTIONS FOR USE

Mixing Directions- Be sure spray tank is thoroughly cleaned. Fill ½ full with clean water, add product, and continue filling with agitation.

Compatibility- N-Star™ is compatible with most fertilizers and biproducts. Always perform a jar test prior to large scale mixing.

SUGGESTED APPLICATIONS

Optimum rate of application will vary between fields depending on soil and/or climatic conditions, stage of crop growth, and size of plants.

Field & Vegetable Crops- Apply 2-8 quarts per acre during vegetative growth every 2-3 weeks as needed.

Permanent Crops- Apply 2-8 quarts per acre starting post bloom and continuing every 2-3 weeks as needed. Apply 1-2 gallons post-harvest.
